

# U Series Championship Player Protection & Liability Policy

## 1. Purpose

The U Series Championship is committed to providing a safe and professional tournament environment. This policy sets out the responsibilities, protections, and disclaimers applicable to all participants, spectators, and associated individuals present at U Series Championship venues.

## 2. Player Acknowledgement

By registering for and/or attending any U Series Championship event, players expressly agree to the terms of this policy, including but not limited to the following:

- U Series Championship is **not responsible** for any personal injury, illness, accident, theft, property loss, or damages that may occur at the venue, including surrounding areas, unless directly caused by proven gross negligence of U Series Championship.
- Players attend and participate in events **at their own risk**.
- Each participant is responsible for their own personal health, safety, and belongings.

## 3. Emergencies & Force Majeure

- In the event of **medical emergencies, accidents, or unforeseen natural events** (such as fire, earthquake, flood, or other force majeure circumstances), U Series Championship representatives may use the personal information provided during registration to **contact family members, spouses, or designated partners** for notification and assistance purposes.
- U Series Championship reserves the right to suspend, modify, or cancel any event in response to emergencies or government/venue directives, without liability for refunds or damages beyond what is expressly stated in the event's registration terms.

## 4. Personal Conduct

- Players must follow all venue safety guidelines, tournament rules, and staff instructions.
- Any disorderly, aggressive, or unsafe behavior will result in immediate removal from the venue without refund.

## 5. Insurance & Personal Responsibility

- U Series Championship strongly recommends that all players obtain appropriate **travel, health, and accident insurance** before attending events. Players are solely responsible for covering their own medical costs, transport, or other personal expenses in the event of illness or injury.

## 6. Media Rights & Consent

- By attending the event, all participants, spectators, and guests **automatically grant U Series Championship and its media team the right to capture photographs, video, and audio recordings** during the event.
- Such materials may be used, reproduced, published, or distributed by U Series Championship for **marketing, promotional, editorial, and commercial purposes**, across any media platform (including but not limited to websites, social media, press releases, livestreams, and broadcasts).
- **No additional release form is required** for this usage, and no compensation will be provided for appearances in such media.

## 7. Limitation of Liability

To the maximum extent permitted by law:

- U Series Championship, its affiliates, sponsors, and representatives shall **not be held liable** for any indirect, incidental, or consequential damages arising from participation or presence at a U Series Championship event.
- U Series Championship's total liability (if any) is strictly limited to the value of the participant's paid tournament entry fee.

## 8. Data Usage Consent

- By registering, players consent to U Series Championship using their personal information for **emergency contact purposes** as described in Section 3.
- U Series Championship will maintain strict confidentiality of personal information in compliance with applicable data protection laws.

## 9. Acceptance of Policy

By entering a U Series Championship event, players acknowledge that they have read, understood, and agreed to this **Player Protection, Liability & Media Policy**. This agreement is binding upon the player, their family, and legal representatives.
